





ASSESSED AND EXECUTED FINANCE STRATEGY TO IMPROVE PERFORMANCE FOR A \$5B MANUFACTURING COMPANY

SITUATION

The client, a U.S. consumer goods manufacturing company, initially engaged FTI to provide an end-to-end assessment of its finance processes and systems following a large reduction in the finance and accounting staff as well as a series of acquisitions.

As a result of the assessment, the client's finance strategy included improving reporting and forecasting processes, rationalizing the global chart of accounts (CoA), developing an integrated, driver-based threestatement model and implementing a new enterprise performance management (EPM) system.

OUR ROLE

FTI Consulting served as the finance strategy and transformation lead to help execute against the strategic roadmap.

- Rationalizing the existing Global CoA, streamlining the number of dimensions and accounts and optimizing the CoA
- Developing CoA functional mapping to integrate during EPM implementation and improve CoA governance processes
- Developing an integrated, driverbased, rolling three-statement model enabling scenario analysis and insight into cash flow
- Standardizing forecasting and reporting templates to be implemented across the company that will integrate into the company's EPM with automation capabilities
- Creating the EPM implementation blueprint for system implementers, outlining technical requirement and business needs
- Designing a simplified business
 planning and reporting cycle and
 managing the reporting output for
 budgeting, forecasting, headcount
 and capital planning
- Reducing the risk of complications, delays or failure of the EPM implementation

CASE STUDY

FINANCE TRANSFORMATION FOR \$1B TECHNOLOGY COMPANY TO SUPPORT AGGRESSIVE GROWTH STRATEGY AND ACCELERATE ACQUISITION INTEGRATION

SITUATION

The client, a global technology company, had experienced a recent change in ownership and was pursuing an aggressive growth strategy and potential future IPO.

To execute on its growth agenda, the client commenced a multi-year Finance transformation with a key focus on shared services leveraging SAP Central Finance.

The client engaged FTI to lead and manage the overall Finance transformation program, and to select a system implementer (SI) for the company's SAP S/4HANA Central Finance implementation as well as drive the project management office (PMO).

CASE STUDY

COST OPTIMIZATION & OPERATING MODEL TRANSFORMATION FOR A \$3.5B RETAIL COMPANY REALIZES OVER \$160M IN ANNUAL SAVINGS

SITUATION

The client is a global specialty retailer and distributor with nearly 30,000 employees and more than 5,100 owned and franchised stores.

The CEO engaged FTI Consulting to review its SG&A, distribution, and product cost structure in order to identify \$25 to \$50 million in cost savings.

The engagement focused on six key areas:

- G&A and Field Streamlining
- Store Labor Optimization
- Inventory Optimization
- Own-Brands Sourcing
- Indirect Sourcing
- Distribution Network Optimization

OUR ROLE

In collaboration with FTI Consulting's Retail Industry experts, our team started with a 7-week assessment which identified ~\$77 million in initial savings opportunities. Our teams worked on:

- Conducting a rapid review of the client's G&A cost structure based on financial and operational data and management interviews with key business and functional leaders at the client
- Understanding G&A spend by function, including headcount and cost benchmarking, service delivery model analysis, compensation analysis, spans and layers review and real estate analysis
- Implementing recommendations to optimize the G&A platform including:
 - Establishing headcount reduction, savings and spans targets for a new G&A structure
 - Developing the future-state organization structure in alignment with the targets
 - Facilitating the "casting" process in coordination with HR and Legal and developing a model to quantify top-line savings and costto-achieve
